The details of the new policy are not yet finalized. Title I is money for low income, while Title III is money for English Learners. With the new policy, Title I and Title III will get more money, as well as preschool. Better tracking of progress for English Learners will also be a big difference in the new policy. The old SES program will go away in the end of school year 2017-18. More updates on this new law will be provided for everyone as received by the district from the state.
