- x Nikki Milevsky commented about the Corvair Monitoring Meeting she attended and that she felt Sacramento City Teacher's Association (SCTA) was not involved in the process. Ms. Milevsky presented a copy of the letter SCTA sent to the U.S. Department of Education.
- x Terrence Gladney spoke about the Local Control Funding Formula (LCFF) and Local Control Accountability Plan (LCAP) meetings.
- x Edward Camargo spoke about the LCFF and LCAP meetings and urged more parents be involved and suggested the agenda be sent out prior to the meetings.

### Board Member Comments

- x Member Rodriguez had a question about information regarding the meetings being posted on the District's website. Chief Communications Officer Gabe Ross responded that meeting information is currently not sent directly to members only posted to the website and expressed appreciation for the public's comments and feedback and that the information would be taken under consideration.
